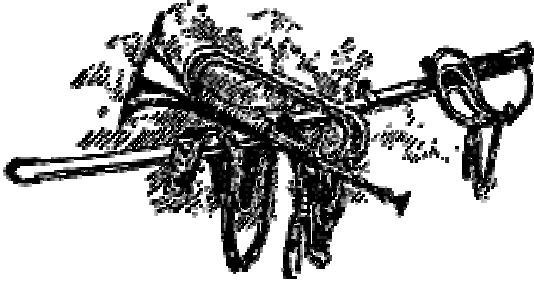

## Battle Roads

An attempt is underway to identify the original roads that Union forces used on the way to and from the battle site. If discovered, these roads might be reconstructed and perhaps incorporated into the reenactment scenario.

## History Mystery

**James Henry Gooding** first appeared in history as a 19-year old who signed on as an ordinary seaman on a whaler at New Bedford, Massachusetts in July, 1856. While at sea he wrote a series of letters that were printed in the **New Bedford Mercury** newspaper. These letters revealed that he had obtained a classical education sometime in his first nineteen years. This was unusual in mid-19th Century America, as Gooding was an African-American.

Historians are puzzled as to how and where Gooding received this education, but thankful that he did. Since most African-American Civil War soldiers were former slaves who could not write, Gooding's letters are one of the few sources of the experiences and attitude of the 186,000 black Americans who served in the Union forces.

Gooding was one of the first to enlist in the famous **54th Massachusetts Volunteer Infantry**. He supplied the **Mercury** with letters on his experiences in the unit on a continual basis. In fact between March, 1863 and February, 1864, the newspaper printed one of his letters almost every week. These letters are compiled in the book **On The Altar Of Freedom: A Black Soldier's Civil War Letters From The Front**.

Gooding survived the assault on Battery Wagner, but was wounded at Olustee while serving as a Corporal. Captured, he was sent to Andersonville prison, where he died. The preface to the book states that, "Gooding's eloquence helped persuade Congress to equalize the pay of white and black soldiers in 1864." What might this **Man of Letters** have contributed to our history if he had lived? A letter from Captain Grace, Gooding's commanding officer, reporting on Gooding's presumed death is available on the WWW site.

## Memorial Services

The memorial service to the Confederate dead has long been a part of the mandatory, Sunday morning parade at the reenactment. Afterwards, a non-mandatory, memorial service takes place at the Union memorial park and cemetery near the railroad tracks.

After standing for an hour on parade it is understandable that many of the reenactors

wish to return to their camps for a late breakfast, last minute sutlering, or to prepare for the 1:00 PM Battle. However, some reenactors do take time to attend the Union Memorial Service. They feel that this service is especially important as many of these dead are still buried on the Historic Site.

As the lone representative of the 15th U.S. Infantry at last February's Union Memorial Service, I wish to extend the CSO's appreciation to the following units for also attending: 17th Connecticut; 54th Massachusetts; 47th, 48th and 115th New York; and a special thank you to the unidentified Confederate unit that joined us in remembering the Union dead.

## Battlefield Kiosks

The artist has received the last recommendations for the design of the new battlefield kiosks. The design has now gone to the Park Service. Everyone involved is working to ensure that the kiosks are in place before next February's reenactment.
